She shared her plan to convert her home into a Senior assessed living home in Frankfort Square. She shared her plans to alter her three-bedroom home into a four-bedroom by converting the garage. She is working with the health department and the county and will keep us informed.

Trustee Kennedy noted he attended the T.O.I. conference in Springfield. It was very educational and informative.

The board wished each other a Happy Thanksgiving.

Nella Piccolin introduced her friend Susan Heaton who will be in training for deputy clerk.

Supervisor George announced that on October 21st we had a very successful paper shredding program. About one hundred fifty cars came to have paper shredded by Shark Shredding.

The Halloween Party was a great success and the decorations were amazing. Thank you, Lucy.

We applied for a \$98,000.00 grant from CDBG and received \$30,000.00 that will be used for heating systems for Autumn Valley Senior Housing.

On December 13th the township will be hosting the Senior Christmas Party at C D and ME from 5:00p.m. to 8:30p.m. The cost for food, entertainment, and beverages, is \$40.00.
