Supervisor George explained that we will be installing a columbarium in the cemetery this Spring. Many people are already interested in purchasing niches, and the township will need to decide what to charge for them.

AARP is doing free taxes at the township and 175 people (the limit) signed up in one day. The Christmas Party for the volunteers went well. Everyone enjoyed it. The volunteers are very appreciated.
