Assessor Budget

Map Amendment for RE: 19-09-14-100-007-0000

Supervisor Moustis explained that a zoning map amendment regarding RE: 19-09-14-100-007-0000 (Parcel = 5.00 ac +/-) will go before Will County Planning and Zoning on February 5th. Kathleen Cartolano of 19350 S. Harlem Avenue, Frankfort, IL 60423 is the owner. She is requesting a zoning map amendment from A-2 to R-2. To subdivide an existing 5 acre parcel into two 2.5 acre parcels. Motion was made by Trustee Ebert and seconded by Trustee Griffin that this board has no objections.

BOARD COMMENTS

Jim Moustis, Frankfort Township Supervisor, reported that the Senior Services of Will County program, Meals on Wheels, will be discontinuing meal delivery on Wednesdays. We will be looking into a ways to provide that Wednesday meal to the people in need in our Township.
