REPORTS

Assessor - Property tax bills have been mailed. We now have the Soft Appeals forms on line. We are currently preparing to hear all the appeal claims as submitted.

Highway Commissioner – Clark Environmental will begin mosquito control in two weeks. There will be six foggings down the streets. The schedule for these foggings will be on our website. The 1-800 number for Clark Environmental will be on the website to contact them directly with any questions.

Supervisor – The Township Bus is now 15 years old. Supervisor Moustis has reached out our State Representatives to request help in finding any information about grants that might be available to help in the purchase of a new bus. He also put forth the idea of having a brunch or luncheon for the several State Representatives and Senators that represent the various areas of our township. The constituency for a couple of these representatives mostly come from Cook County. These representatives know very little about what programs and services are provided by townships. A tour of our township and our services would broaden their understanding of how we save the county and state a great deal of money every year.

Trustees – Dave Smith reminded us that the United States Post Office food drive will take place this Saturday, May 13th, 2017. The township will be getting deliveries of contributions beginning about 10:30a.m. If you can donate an hour or so of time the township will be open from 10 a.m. until 2 p.m. Recommended that you come about 10:45 or 11:00a.m. to unload, sort, and fill the Food Pantry shelves.

Nick George reported that the new well that will be servicing the Arbury Hills area/Mokena area is on a new aquafer about 900 feet deep. This project is under the direction of the Commerce Commission and not Frankfort Township. Due to the cost of running these utilities, we will probably see more privatization of same.
