### 1. Annual Town Meeting – establish July 21st 2020 date

Supervisor Moustis informed the board that the governor signed HB 2096 (Public Act 101-0632). After following meeting posting requirements the township is allowed to have the Annual Town Meeting in July 2020. The Act implies that the township may wait until there is no longer a declaration in effect, if not in July.


Our Event Center is not open, but we are planning to open with the new COVID-19 guidelines.
