## **REPORTS**

Bill Carlson, Highway Commissioner, reported that all work is complete on the new streets, curbs, landscaping restoration, and sidewalks on the four streets in Arbury Hills. This was funded with Motor Fuel money. The Township Road District has secured a new contract for salt with CMS and we should have no problems with salt for this winter. In the next two weeks he will remove and replace another 200 trees due to the Emerald Ash Borer infestation.

Jim Moustis, Frankfort Township Supervisor, reported that the Township Event Center is complete and the township now has a few booking for parties. The Northern Illinois Food Bank provided the township with a new generator and electric panel to insure that the refrigeration in our building will not be affected during storms. The Township is responsible for its installation.

Joe Kral, Assessor, stated that home sales and building permits have increased in our township. This is a sign of renewed momentum in residential real estate. He also noted that the township did a great job on the dedication of Townline Road as Aaron Toppen Memorial Drive.

Trustee Griffin will be working on obtaining a donation for signage and a gate for the Township Cemetery.
