BOARD COMMENTS

Assessor Joe Kral informed the board that the preliminary three year average property assessment in Frankfort Township has increased by over 9 1/2 percent for all properties. Everyone will be receiving a notice by mail in late August that will show a 9 1/2 percent assessment increase to their property.

Supervisor Jim Moustis noted that the next tax bills will have an additional line item for mental health. This will be an average cost of about \$150.00 per person.

The board congratulated and welcomed Thomas Kennedy, our new collector. Trustee Nick George and the board thanked Ryan Compton for showing interest in the township's environmental sustainability. He is working towards becoming an Eagle Scout.
